WITH RESPECT TO ITS FORM 10-K FOR THE FISCAL YEAR ENDED DECEMBER 31, 2013

The Registrant estimates that its results of operations for the year ended December 31, 2013, as reflected in its consolidated statements of operations to be included in its Form 10-K for the year ended December 31, 2013, will reflect the following changes:

For the year ended December 31, 2013, the Registrant expects to report an increase in revenues to approximately \$13.37 million from approximately \$12.70 million for the year ended December 31, 2012. For the year ended December 31, 2013, the Registrant expects to report net income of approximately \$1.53 million, compared to net income of approximately \$4.28 million for the year ended December 31, 2012. The decrease in net income for the year ended December 31, 2013 was largely attributable to a reduction in other income.

Also, for the year ended December 31, 2013, the Registrant expects to report net income per share - basic and diluted of approximately \$0.17 and \$0.16, respectively, compared to net income per share – basic and diluted of \$0.62 and \$0.57, respectively, for the year ended December 31, 2012.
